**TAKE ME OUT: APPLICATION TERMS & CONDITIONS**

### **1. General guidelines**

These terms and conditions relate to your application to participate in the television dating show entitled "Take Me Out" (Series 1) (the "**Programme**") which FremantleMedia Limited trading as TalkbackTHAMES (the "**Production Company**") proposes but does not undertake to produce for ITV. The information given by you in your application may be used in the Programme should you be selected.

You acknowledge and agree to abide by these terms and conditions, and that these terms and conditions may be changed (including without limitation verbally) at any time by the Production Company and that you will be bound by such terms and conditions. The Production Company's decision shall be final.

### **2. Eligibility requirements**

To be eligible to apply to participate in the Programme, you must meet the following eligibility criteria:

- (a) You must be a resident of the United Kingdom and hold a valid passport; and
- (b) You must be single and aged eighteen (18) years or over at the date of application; and
- (c) You must not be employed, and have not been previously employed or engaged by, and must not be a live-in partner or immediate relative (i.e. mother, son, daughter, brother or sister) of an employee at the Production Company or the ITV Plc group of companies, or any of their subsidiaries and/or agencies associated with this competition; and
- (d) You must disclose to the Production Company details of any/all criminal convictions and actions pending against you currently and/or any unspent convictions other than driving offences which have not resulted in a ban.

By applying to participate in the Programme, you promise that you are eligible to apply, that the information you provide at the time of applying is correct, up to date, and is not misleading in any way, and you agree to be contacted by the Production Company, at their discretion. There is no restriction on the number of times you may apply.

Application forms which are sent and/or received by the Production Company after the stated deadline or which are false, misleading, incomplete, inaudible, incomprehensible, incorrectly addressed, lost in transit, with insufficient postage, or not received are invalid and will not be considered. The Production Company reserves the right in its sole discretion to invalidate any application received. The Production Company cannot accept responsibility for any application which is not received by the stated deadline.

The Production Company and/or ITV will only pass an applicant's data to third parties for marketing purposes if that applicant has asked to receive marketing information from those third parties. Any information and other data which is provided by you when you apply will be held and used by the Production Company, ITV and their sub-contractors in order to administer your application and for the production and promotion of the Programme. This may include but is not limited to the Production Company using the information you provide to verify your age and identity and to carry out background checks with law enforcement and government agencies.

If an applicant cannot be contacted, or is not eligible and/or does not comply with these terms and conditions as specified, then the Production Company reserves the right to invalidate the application. The decision of the Production Company is final.

You may be invited to attend an audition at a time and place to be notified by the Production Company. The Production Company cannot guarantee that you will be offered an audition or that you will be offered an audition in your preferred city.

Following the auditions applicants will be selected to take part in the Programme at the sole discretion of the Production Company whose decision will be final. The Production Company cannot guarantee that unsuccessful applicants either at application stage or after the audition stage will be contacted.

If you are invited to attend an audition you hereby grant all consents necessary for the Production Company to film and record such audition and to use recordings featuring your image and/or voice in connection with the Programme and/or ancillary rights in the Programme and to exploit the same in all media throughout the world in perpetuity without the need for payment to you.

If your application is successful, it is your responsibility to ensure that you are available at the times as specified to attend the location of the audition and/or filming of the Programme if applicable. It is your responsibility to bring valid proof of age and eligibility and to make your own way to such specified location, unless otherwise stated. You will be required to comply with any directions and/or instructions given to you, including, without limitation, in regard to conformity with the Ofcom Broadcasting Code, health and safety instructions and all relevant laws, rules and regulations. Failure to provide valid proof of age and eligibility or to comply with any directions or regulations will result in you no longer being permitted to proceed further.

You will not, without the Production Company's prior written consent, disclose, publish or discuss with any third party any information relating to the audition process, the Programme, your appearance in the Programme, the production team or any participants in the Programme or any other information which may come to your attention including without limitation any information relating to ITV, the Production Company or otherwise save where such information is already in the public domain.

Should you be selected to take part in the Programme you may be required to enter into further contracts with the Production Company and agree to abide by the terms therein and agree that failure to do so may result in you being withdrawn from the application process and forfeiting all rights as a participant without further notice.

Neither the Production Company nor ITV is liable to refund any costs or expenses incurred in applying, or in participating in the Programme, including but not limited to the cost of calls made, postage, internet access fees, travelling expenses, transportation, accommodation, meals, drinks, insurance, taxes and costs unless otherwise provided for.
